

Parent/Legal Guardian Consent Form (FORM 3)

For their child's participation in the 56th International Children's Art Exhibition organized by the Biiku Bunka Kyokai (Interest Incorporated Foundation of Japan for Culture of Art Education) **(the "Exhibition")**

I. I consent to my child's participation in the Exhibition:

II. I consent to the processing of my personal data by the organizers of the Exhibition for purposes arising from the organization of the Exhibition in accordance with the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27th April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation).

III. I consent to the inclusion of my child's personal data on the websites and social media posts of the organizers of the Exhibition in publications related to the Exhibition, in particular, informing people about the results of the Exhibition.

IV. In addition, I agree to repeated, free of charge and unlimited in time publication of the Exhibition work created by my child in promotional materials related to the Exhibition, in the occasional publication, on the websites and social media posts of the organizers and in other recorded forms.

At the same time, I declare that I have been informed that:

- 1. The administrator of my personal data is **the Biiku Bunka Kyokai** with its headquarters in 5-19-4 Takenotsuka, Adachi-ku, Tokyo, Japan.*
- 2. The personal data of my child that I have provided will be transferred to Japan (a so-called third country) and the adequate and appropriate safeguards required by the regulations on personal data protection will be in place.*
- 3. The personal data of the Exhibition participants will be processed for the period necessary for the implementation of the Exhibition in accordance with article 6 section 1 letter a of the General Data Protection Regulation ("RODO"). Personal data will be stored for the period of the Exhibition, its promotion and summary on the websites and social media posts of the Exhibition organizers, and for the period required by law.*
- 4. The basis for the processing of personal data is my consent to the processing of personal data.*
- 5. I have the right to access the content of my child's data, and correct, delete, transfer or restrict its processing.*
- 6. If I believe that the processing of personal data has violated the provisions of RODO, I have the right to lodge a complaint with the President of the Office for Personal Data Protection.*
- 7. Personal data will not be processed by automated means, including profiling.*
- 8. The provision of my and my child's personal data is voluntary, but it is necessary for the child's participation in the Exhibition.*

I also declare that I have read and accept all terms and conditions stipulated in the Exhibition regulations.
